With reference to the subject cited above, all the Registered Pharmacists of Andhra Pradesh State are hereby informed that the PCI, New Delhi has signed MOU with LSSSDC for Skill Development and Entrepreneurship under funding support from Pradhan Mantri Kaushal Vikas Yojana (PMKVY 4.0) for "Upskilling and Certification Program of LSSSDC in Life Sciences Sector".

The project has total of 26,500 seats for the Registered Pharmacists for Upskilling and Certification by LSSSDC. This is a good opportunity for State Pharmacy Councils in Southern Region to Up-skill and certify the registered Pharmacists for their future growth and enhancing the Skills for efficient performance in Pharmacies. The initially project will start from southern states. Around 6000 Registered Pharmacists of Andhra Pradesh will be benefitted @150 batches and each batch consists of 40 Pharmacists. The State Pharmacy Council has identified and approved fifteen (15) centres in AP.

Training Duration : Mandatory 30 hours (including 4 hours for Program Orientation and Mock Assessment Practice) + 2-3 hours for Mandatory assessments

Daily Training Hours : 08 Hours

Total Days of Training : 04 Days

Centre branding T-Shirts will be distributed to enrolled Registered Pharmacists.

2 Lakhs accidental insurance for 1 year will be provided for certified candidate.

As per regulation 4.2 of the Pharmacy Practice Regulations, 2015, the Pharmacist shall attend minimum of two (2) refresher courses (CEP) in a span of 5years. Certificate will be issued after completion of course which is a mandatory for renewal of registration.

In view of the above, all the Registered Pharmacists of Andhra Pradesh are requested to utilise this opportunity and enroll your name on Skill India Digital Hub (SIDH) on or before 15.11.2024 @ 5.00PM by approaching the nearest training centre.
