You are all hereby informed that, the Pharmacy Council of India vide reference above cited(1), declared that the Circular issued by Pharmacy Council of India vide ref(2) is null and void.

As per the Circular vide ref(2), Pharmacy Council of India has withdrawn the proposal of conducting the "**EXIT EXAM**" for Diploma in Pharmacy Certificate holders 2022-23 admitted batches.

In-view of the above, the Diploma in Pharmacy Certificate holders of 2022-23 admitted batches who were issued Registration Certificates already by Andhra Pradesh Pharmacy Council as per the instructions of Pharmacy Council of India, New Delhi, are requested to obtain Registration Certificates from Andhra Pradesh Pharmacy Council on par with the Regular Registration Certificates issued to the D.Pharmacy Certificate holders U/S 32(2) of Pharmacy Act, 1948 by surrendering the Original Registration Certificates issued to them through Speed Post to Andhra Pradesh Pharmacy Council.

These Registered Pharmacists have to enclose, one A3 size Self Addressed envelope affixed with the stamps worth Rs.85/- for receiving the Registration Certificate from Andhra Pradesh Pharmacy Council.
